3. CATEGORIES OF PERSONAL DATA PROCESSED As part of this treatment, the identification data are processed to self-certify the absence of symptoms attributable to the Covid-19 virus. Limited to the specific purposes indicated below, the personal identification data and the data suitable for revealing health (art.9, par. 1 of the GDPR 2016/679) may be processed with exclusive reference to the body temperature detected to access the premises and the environments

of Fattoria Il Torrione .4. THE PURPOSES, THE LEGAL BASIS OF THE PROCESSING AND THE NATURE OF THE CONFERENCE

To access the rooms and premises of the headquarters of the Data Controller, it is necessary to sign the model in question stating the absence of symptoms of Covid-19. In support of the preventive measure in question, the owner uses infrared thermometers for real-time detection of body temperature when entering the structure. This measure is necessary to prevent the spread of the coronavirus COVID-19, also pursuant to what is indicated in the "Shared protocol regulating the measures to combat and contain the spread of the Covid-19 virus in the workplace" signed in first entered on 14 March 2020 and then modified on 24 April 2020 and the indications of the Guarantor for the protection of personal data The purpose of this treatment which does not provide for the recording of the temperature detected in compliance with the anonymity principle enshrined in art. 5 of the GDPR 2016/679, is exclusively aimed at enabling or inhibiting access to the areas and premises of Fattoria Il Torrione and finds its legal basis in the need to fulfill a legal obligation to which the Data Controller is subject (art.6 letter c) of the GDPR) or the implementation of the anti-contagion security protocols pursuant to art. art. 1, no. 7, lett. d) of the Prime Ministerial Decree of 11 March 2020. The provision of personal data referred to in paragraph 3 is mandatory in order to allow you access to the Il Torrione farm headquarters, therefore access will be denied if the body temperature detected is higher than 37.5 °, as required by the Protocol.

5 RECIPIENTS OF PERSONAL DATA - COMMUNICATION AREAS

Your personal data will be processed by the internal staff of the Data Controller duly authorized and in charge of the processing as well as appropriately trained in the security of personal data and the right to privacy. The communication of your personal data to third parties can only take place if such communication is required by specific regulatory provisions, for example in the event of a request by the competent Health Authority for the reconstruction of the supply chain of any close contacts of a result subject positive to Coronavirus. Your Personal Data will not be disclosed.

6. TRANSFER OF PERSONAL DATA TO THIRD COUNTRIES OR INTERNATIONAL ORGANIZATIONS

Your personal data will not be transferred to third countries or international organizations.

7. STORAGE OF PERSONAL DATA

Any personal data collected as part of the treatment in question will be kept by the Data Controller until the end of the state of emergency decreed at national or local level as a consequence of the spread of COVID-19. In any case, once the state of emergency has ceased, any personal data stored by the Data Controller pursuant to this information will be deleted by the Data Controller itself.

8. DATA SUBJECT'S RIGHTS

The interested party has the right to ask the data controller for access to personal data concerning him, the correction or cancellation of the same, the limitation of the treatment, the portability of the data, he has the right to oppose the treatment, to propose a complaint to a supervisory authority. The interested party has the right to withdraw the consent at any time without prejudice to the lawfulness of the treatment based on the consent given before the revocation. For the complete and exhaustive list of the rights exercisable by the interested party, see art. 15 and following of the GDPR 2016/679. It is possible to exercise the rights of the interested party by contacting the Manager
